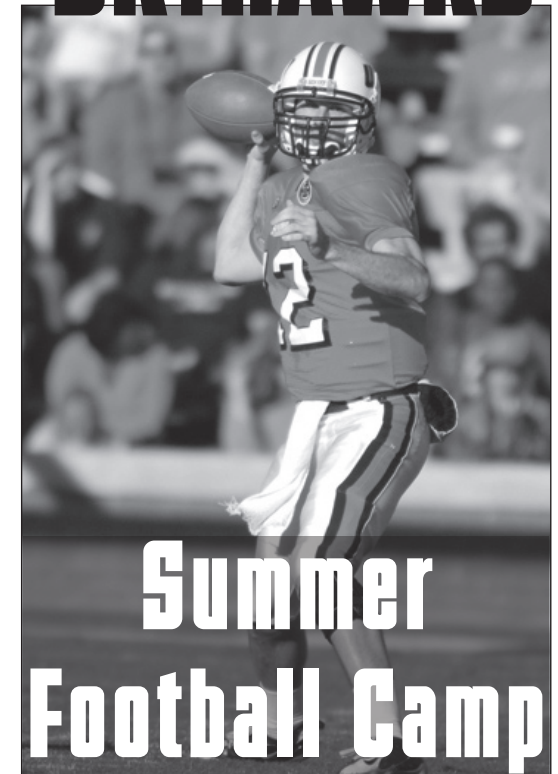

### *Registration*
