You may apply for housing at the same time you apply for admission. You may also apply for housing at a later date. If you apply for housing and admission at the same time, send a check for \$130 payable to UT Martin. This covers the application fee and housing prepayment for the residence halls; if you are applying for University Village, send \$180 to cover the application fee and deposit. If you apply for housing at a later date, send a check for \$100 for the residence halls; or send \$150 if applying for University Village. Make checks payable to UT Martin.

If you want to apply for **housing ONLY**: Complete all requested information and return this form with \$100 prepayment for the residence halls or \$150 deposit if applying for University Village. (No prepayment is required for summer semester in the residence hall.) Make check or money order (do not send cash by mail) payable to UT Martin.
