Unconditional Waiver of Liability

Therefore, in return for the privilege of participating in the Martin Kiwanis Club/City of Martin Christmas Parade, I hereby give this, my unconditional waiver of liability and hold harmless agreement, to and in favor of the Martin Kiwanis Club and City of Martin, together with all of its organizers, officers, directors, and staff.

By executing this waiver form, I do hereby state that I have the actual and legal authority to bind the organization on whose behalf I am executing same. Furthermore, I individually, and the organization upon whose behalf I am acting, agree to forever release and discharge the Martin Kiwanis Club, the City of Martin, together with all of their officers, directors, staff and employees, together with the organizers of the Martin Kiwanis Club/City of Martin Christmas Parade from any and all liability for any injury or harm that I individually, or my organization may suffer as a result of participation in said parade or any activities that are preparatory or subsequent thereto.
